### HANDLING INSTRUCTIONS

1. The customer is responsible for keeping the sample in the same condition in which it is received.
2. Return the sample on the original hanger, in the same poly bag, and in the same box as received.
3. Lay the sample flat in the box, folding once.

### SHIPPING INSTRUCTIONS

1. The garments will be shipped UPS ground at customer expense. Air freight can be requested and quoted.
2. The customer is responsible for the return shipping charges.
3. The customer must **insure the freight when returning** back to Siri.

### LOAN PERIOD

1. Date customer requests the sample to be received:        /        /
2. **The sample may only be kept for 2 days.** A **late fee** of **\$50** will be charged for any delay in return.

### COSTS

1. UPS shipping charges to a USA destination is \$25 for ground shipping plus \$7 for each additional garment; or \$60 for 3-day air shipping plus \$7 for each additional garment. For a Bridal Gown, the charge is \$35 for ground shipping plus \$12 for each additional gown; or \$70 for 3-day air shipping plus \$12 for each additional Bridal gown.
2. UPS ground shipping charge to Canada is \$35 plus \$7 for each additional garment. For a Bridal Gown the charge is \$60 plus \$12 for each additional gown. Duty is paid by the customer.
3. Cost of garment(s) if not returned or percentage thereof if damaged
4. Loaner fee per garment is \$10 (\$25 for Bridal styles); one garment fee is waived for any one garment ordered. Loaner fee and shipping charges are charged to customer's credit card; AND the total style cost is processed as an \*authorization hold on customer's credit card.

**\*Authorization hold: a hold will be place on your credit card by YOUR financial institution from 7 to 28 days.**
